- Provides education to schools and other organizations outside TGP related to children and family concerns around cancer

- Serves on TGP committees and participates in administrative activities as assigned
- Attends staff meetings
- Attends Board meetings as needed
- Communicates programming needs for volunteers, trains and supervises volunteers involved in children and family programming with Volunteer Services Manager
- Participates in bi-monthly clinical peer supervision and monthly group supervision of contract staff
- Participates in clinical programming for the adult population as appropriate
- Seeks opportunities for professional presentations/publications
- Participates in continuing education activities for personal and professional growth
